Convinced that high-quality research leads to better clinical practice, the SAMS set up the funding program «Research in Palliative Care» with the support of the Gottfried and Julia Bangerter-Rhyner and Stanley Thomas Johnson Foundations to strengthen the research capacity in palliative care in Switzerland. A discipline with a growing importance in a society where near 90% of the population dies after a prolonged period of illness requiring end of life care. The closing symposium on the program, which supported 38 projects from 2014 to 2018, offers the opportunity to discuss how research findings can be implemented in practice and how palliative care research can be supported on the long term in Switzerland.
